**Subject:** Re-designation of the post of Sub-Assistant Engineer as **Junior Engineer** and Re-orientation of the post of Sub-Assistant Engineer from Subordinate Service of Engineers, West Bengal to **Junior Service of Engineers, West Bengal.**

Sir,

With due respect, on behalf of our Association, we stating some salient points in favour of subject mentioned 'Re-designation of the post of Sub-Assistant Engineer as **Junior Engineer** and Re-orientation of the post of Sub-Assistant Engineer from Subordinate Service of Engineers, West Bengal to **Junior Service of Engineers, West Bengal**, which are mentioned below.

1. In the year 1980, Ministry of Works & Housing (Works Division), Govt. of India in their letter No. 2633 EW2/80 dt. 23.02.80 & No. 28017 (10)/80 – EW2 dt. 21.10.1980 requested to Chief Secretaries of different State Government & Union Territories under Govt. of India for Re-designation of above mentioned post for maintaining uniformity of the post where recruitment of Diploma Engineers been made throughout all the States & Union Territories under Govt. of India at the same time Re-orientation of service accordingly.
2. All most all the States & Union Territories under Govt. of India have Re-designated of the post of Diploma Engineers in to Junior Engineer giving honour to the Govt. of India. Like Uttar Pradesh, Haryana, Rajasthan, Punjab, Bihar, Tripura, Asam, Orissa, Jharkhand, Madhya Pradesh, Uttarakhand, Jammu & Kashmir, Himachal Pradesh, Maharashtra, Gujrat, Karnataka, Meghalaya, Tamilnadu, Andhra Pradesh, C.P.W.D. & all Union Territory of India implemented "Junior Engineer" Designation to their State years together ago. In this connection, some available documents like Uttar Pradesh, Haryana, Rajasthan, Punjab & Bihar are attached herewith for your ready reference.
3. In our State the highest constitute body like Public Service Commission, West Bengal regarding service matter have recommended in favour of same Re-designation vide letter No. 70 P.S.C. (S&R)/2M-1/03 dt. 8<sup>th</sup> August 2003, which is attached herewith.

4. Hon'ble 2nd Pay Commission, West Bengal 1977-1980 in their Report Book, Page 90 Para 21 have supported in favour of Re-designation of the post of Sub-Assistant Engineer to Junior Engineer. Xerox copy of the same report is attached herewith.
5. In West Bengal in favour of Re-designation a file under reference has been moved in the year 2006. But the then State Govt. ruled by Left front have not issued any order in favour of the same due to some invisible cause.

So our request to your goodself to issue an order in favour of our Re-designation of the post of Sub-Assistant Engineer as JUNIOR ENGINEER and Re-orientation of our service from Subordinate Service of Engineers to JUNIOR SERVICE OF ENGINEERS.
